Mr. Ederer,

In your response to my letter dated 11/30/12 you stated that "The Board has been in communication with the City of Rye regarding the missing tanks." This is my second request as to whom the Board has contacted in the City of Rye and what their position was.

Reviewing your response, I find your statement "martine recovery of these items are virtually impossible." to be inaccurate and a total fallacy. This appears to be another situation where the Hen Island community is avoiding its responsibility in protecting the health and safety of its residents and the residences of Rye.

Is it your contention that the 100 lb. propane tanks that have been deposited in the waterway between Hen Island and Green Haven should remain until an innocent unsuspecting boater collides and detonates the underwater tanks? Is it also your contention that the City of Rye has agreed to allow Kuder Island Colony to abandon the tanks in question in Milton Harbor? Are you aware that Hen Island is centrally located where over a thousand boats are moored or docked seasonally? Are you aware that the Army Core of Engineers spent two weeks in Milton Harbor studying the underwater bed topography damage after the storm? Are you aware that the same or similar equipment can be used to identify locations and remove the tanks? You should also be advised that most commercial marine contractors are capable and equipped to handle the recovery and location of the 100 lb. propane tanks in question.

Additionally, I have polled six homeowners and they have confirmed that they were never queried about missing tanks. I would suggest that a complete inventory be taken at the first available opportunity.

It should be noted that your reference to homes, docks, decks, walls, automobiles and oil tanks in your response are items that are not explosive under water, such is not the case with propane tanks. Propane tanks are highly explosive when contact is made with high rpm boat propellers and therefore they should not be abandoned underwater where innocent boaters are subject to decapitation, dismemberment or death if contact should occur. Once again, if you were instructed by someone from the City of Rye that the abandonment of the tanks in question is acceptable please advise me as to whom it was, so I may confirm the same.
