Re: Hen Island The Movie—Misrepresentations & use of likenesses without consent


Dear Mr. Tartaglione:

The Kuder Island Board has reviewed your Hen Island film trailer, and has asked this office to bring certain problems to your attention for your remediation. Initially, Kuder Island is concerned that the “cast list,” without permission, includes photos of Kuder Island shareholders, Ben Minard, Michael Johnson, Helen Cunningham, Gary Ederer, Martin Ederer, Lorraine Volpe, as well as Ira Goldenberg from this office which has represented the Kuder Island Board in prior legal matters. In the view of the Kuder Island Board, the views and actions you have attributed to these people in your under-their-photo summaries of them include misstatements and distortions of fact—both directly and by omission of context—some of which are so blatant as to leave an impression completely at odds with the truth of the matter.

The Board views the intentional use of these people’s names and photographs without permission as both an invasion of their privacy and a violation of their right to control the use of their own identity as protected by the New York Civil Rights Law. Additionally, the Board finds your distortion of the facts surrounding their views and actions to be libelous.

Please remove these shareholders and your summaries about them from your “cast list.” And if you have included in the film itself any statements made by these shareholders or other shareholders on the island who may not be named in the “cast list” (other than statements made in a public forum such as city council meetings), without the surrounding context of such statements, please also remove those portions of the film or supply the missing context. This letter is intended as a fair warning to avoid the need for legal action, including injunctive relief to assure the necessary changes are made.
